

In this connection I should like to have a few minutes of your time some time this week or next at your convenience, in order to bring to your attention certain matters in relation to the Library sites and other Library matters.







Dear Sir:

An appropriation was made by the Board of Estimate and Apportionment on May 14, 1909, in the sum of \$510,000, by the issue of corporate stock, for the acquisition of sites for libraries under the provisions of Chapter 580 of the Laws of 1901, and of the contracts between the City of New York and the respective libraries, relative to the gift of Andrew Carnegie, dated July, 1901.

These contracts provide that the Board of Estimate and Apportionment shall proceed to acquire title by gift, purchase or condemnation to such sites as shall be necessary on the approval in each case of the libraries.

In June of last year the Trustees of the libraries accordingly approved of thirteen sites.

I beg to suggest that it is therefore the duty of the Board of Estimate and Apportionment to proceed without further delay to acquire title there-
to.

On January 21, 1910, the report of the Comptroller recommending the acquisition of these sites, within the appropriation, was laid on the table by the Board of Estimate and Apportionment.

The only question which is before the Board of Estimate and Apportionment at this time is upon the report of the Comptroller as to whether his recommendations as to purchase and condemnation should be approved.

The properties which it is recommended to be purchased at private sale, can be acquired at reasonable prices, very much under what would have

to be paid in condemnation proceedings. Out of 55 sites for libraries, it has been possible to acquire to date 44 by private purchase at reasonable prices. It would be unfortunate should it be necessary to avoid consummation of the pending negotiations and lose the opportunity of acquiring these sites at reasonable prices.

It is recommended that six sites be acquired by condemnation proceedings. If the Board of Estimate and Apportionment will authorize proceedings to be taken, it is my judgment that this will be sufficient to bring the property owners to reasonable prices. I do not contemplate that it will be necessary actually to carry forward condemnation proceedings, but that with the prospect of condemnation proceedings and the long delays incident thereto, it will be possible to induce the owners to accept reasonable prices for their property.

I, therefore, urge that you cause the matter to be taken from the table at the next meeting of the Board of Estimate and Apportionment, and that the Board



authorize the acquisition of the properties recommended for private purchase, and also properties recommended to be condemned.

In this connection I beg to hand you herewith a copy of a report which I made to the late Comptroller, and which he transmitted to the Board of Estimate and Apportionment, bearing date April 19, 1909, which will illustrate to you what has been done in the matter of acquiring sites for libraries. A perusal of this report will, I think, illustrate to you not only what can be done in the matter of acquiring properties at reasonable prices, but will show to you economical administration of this undertaking.

I, therefore, have respectfully to request that you give this matter your urgent attention. In case you desire any additional information I shall be glad to call upon you.
