



Dear Sir:-

Your letter of July 29th, was received and the matter of the polling place in the 13th Election District of the 13th Assembly District, was investigated, and it was found at that time that the place selected, 24 Amsterdam Avenue, was of ample size, cleanly and well-located, and the fact that the polling place had been located there nearly every year for the last seven years, it was decided not to make any change. The following shows our record of the location of the polling place in that election district since 1906.

In a great many instances, it would be very difficult to get polling places if we required the owners of places to be citizens. The test simply being the necessary size, sanitary conditions, and location of such place, and we cannot very well make any discrimination as to the citizenship of the owner; should we do so we might find ourselves in a great many instances without polling places.

This matter has been called to our attention at this time by a letter forwarded to us by the direction of the Mayor of the City, and we are now sending you a reply which you should have received sometime ago.
