I ARRIVED AT the ball room AT ABOUT 2:30 PM  
AND WALKED AROUND the hall. I WAS A member of the  
SECURITY. WHILE I WAS WALKING I SAW Thomas 15X Johnson  
seated around booth 47 or 49. IN the rear portion of  
the hall I brought this to the attention of Ruben  
Francis, Francis told me that everything was under  
control. I then went to booth 15 or 17 and sat down  
with Brother Matthew. After awhile Malcolm was  
introduced by brother Benjamin. At this time there  
was some confusion in the center of the hall and  
someone yelled "Get your hands out of my pocket"  
A man got up and he held a gun in his hand I  
have seen this man before at Mosque #7. He is  
Talmadge Hayer. Then the second man got up and I  
saw that he was Norman 3X Butler. At this time  
I heard a shot from the front of the hall by  
the stage I looked in that direction and saw the  
back of a man. the man then turned to his  
left and I saw that he was ~~Norm~~ Thomas Johnson  
and he was holding a shotgun. the crowd began  
to scatter and Johnson was lost in the crowd. At  
this time Butler & Hayer ran to the front of  
the stage and fired shots into the prone body  
of Malcolm X. I then hit the ground and



remained there until it was over, I then went to the stage and remained with Malcolm until he went to the Hospital. I then went back to the Hotel Theresa.

testify when required from the fact that the Third March 1965 New York County Grand Jury is presently investigating the criminal homicide of Malcolm Little, a/k/a Malcolm X, which occurred on February 21, 1965, in the Audabon Ballroom, in New York County. Cary Thomas, Jr., is a material witness and has vital information concerning this slaying in that he was physically present in the Audabon Ballroom at the time when the deceased was shot and killed and has information concerning the identity of the perpetrators. The witness, Cary Thomas, Jr., has several times told me that he is in fear of his life because of the information which he possesses in this case. Your deponent verily believes that there is substantial reason for the life and safety of the witness, Cary Thomas, Jr., and due to the nature of the case and the people involved said Cary Thomas, Jr. may be intimidated or otherwise prevented from appearing when required and may flee the jurisdiction of this court. Cary Thomas, Jr. is at present not employed; he is separated and not living with his wife and has no permanent roots in the community.

Wherefore deponent prays that the said Cary Thomas, Jr.

be required to give sufficient security to assure his attendance when required as a witness or  
upon refusal to furnish such security that he be committed to the House of the Detention  
of Witnesses, (or the Civil Jail of the County of New York) until he be legally discharged.

It is hereby ORDERED that the said Cary Thomas, Jr. enter into a written undertaking with good and sufficient sureties in the sum of \$ 50,000 dollars for his appearance as a witness against the said defendant; and

It is further ORDERED, if the said Cary Thomas, Jr. fail to furnish such undertaking for his appearance, that he be committed to the House for the Detention of Witnesses (or the Civil Jail of the County of New York) until he gives such undertaking or be legally discharged.

It is further ORDERED that the Commissioner of Correction or (or the Sheriff of the City of New York) his duly authorized agent is authorized and directed at any time upon written request of the District Attorney of New York County, to deliver the said witness to a police officer of the City of New York for the purpose of taking him to court or to the office of the said District Attorney, and thereafter returning said witness to the said House of Detention (or Civil Jail).

That is to say Sir was the results of a perfect misunderstanding.

I don't wish to take up your time with a long description. However it would be highly appreciated here if you would investigate the matter. A.D.A. Herbert Stein has knowledge of this. I wish to contend that I was a victim of incompatible circumstances.

you. Will you please grant me this?

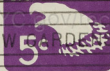

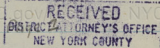

Now right after the big bang during the week before the PINK Act. 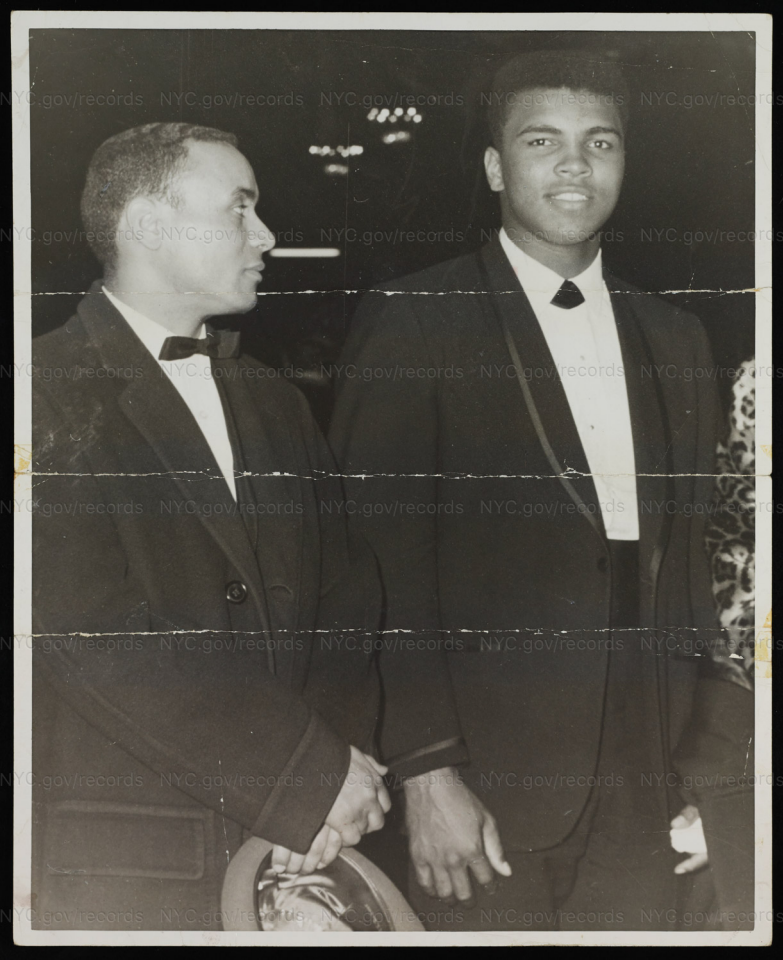

Butler on his left. Hayer got up & backed up & said  
"Now what you doin with your hands, get your hand out of my  
pocket, (saw Butler a few times, knew him as Norman 3x  
he was a uncle of museum? when I was there before Malcolm  
& left. I have greeted him "Selom aleichen") Hayer stood  
up in a crouch & backed off & took a gun from inside  
his coat. (People started to get out of the way) Some security  
brother approached Hayer. Butler went to his left & forward  
just then another man ran toward the front stage just me,  
Malcolm & moved to the right of podium. Just then a  
blast went off. The man that ran past me toward the  
stage was another brother (I saw him earlier seated  
in the rear booth (49, 631) he was a member of #7  
he was Thomas 15x Johnson. The blast might have gone off  
just after <sup>Johnson</sup> he past me. Johnson & Butler met in front  
of the stage leaving over stage toward Malcolm & who  
was lying on the stage the same position their hand  
(both right hand in manner not bringing hand  
all the way back but slightly) I heard shots coming from  
the front as they (Johnson & Butler) were running over the  
stage toward Malcolm. In their hands (Butler & Johnson)  
they had guns & I heard gunshots from that place (up front).

I have seen Johnson before on the street in groups & selling papers (Grosque papers)  
I am positive without a doubt it was Thomas Johnson who on past me, who had one stage shot a gun in his hand.
