
Your letter of the 1st instant enclosing a letter from Raphael Esturo with reference to his application for citizenship papers received.

Investigation in his case shows the following record:

Esturo filed his petition for citizenship papers in this office on April 1, 1907, the same was thereafter put on the calendar for July 2, 1907, and when the case was reached in its regular order on such calendar no appearance or answer was made by him. The case was again placed on the calendar for September 27, 1907 when he appeared, was examined, and the case set over to November 7, 1907 by Mr. Justice Crane. The case appeared on that date, November 7, 1907, and no appearance or answer was made by him. The case was again placed on the calendar for January 30, 1908, and again no appearance or answer was made on that date. His case was then set down by Mr. Justice Carr for February 27, 1908 when he again failed to appear and answer on that date, and on motion of the United States District Attorney, the petition was denied.

The petitioner received due notice of each adjournment and of the dates when his case would appear on the calendar.


I have also to request permission to make a correction in two (2) of the Budget line titles as submitted, which should read,-


Dear Sir:-
