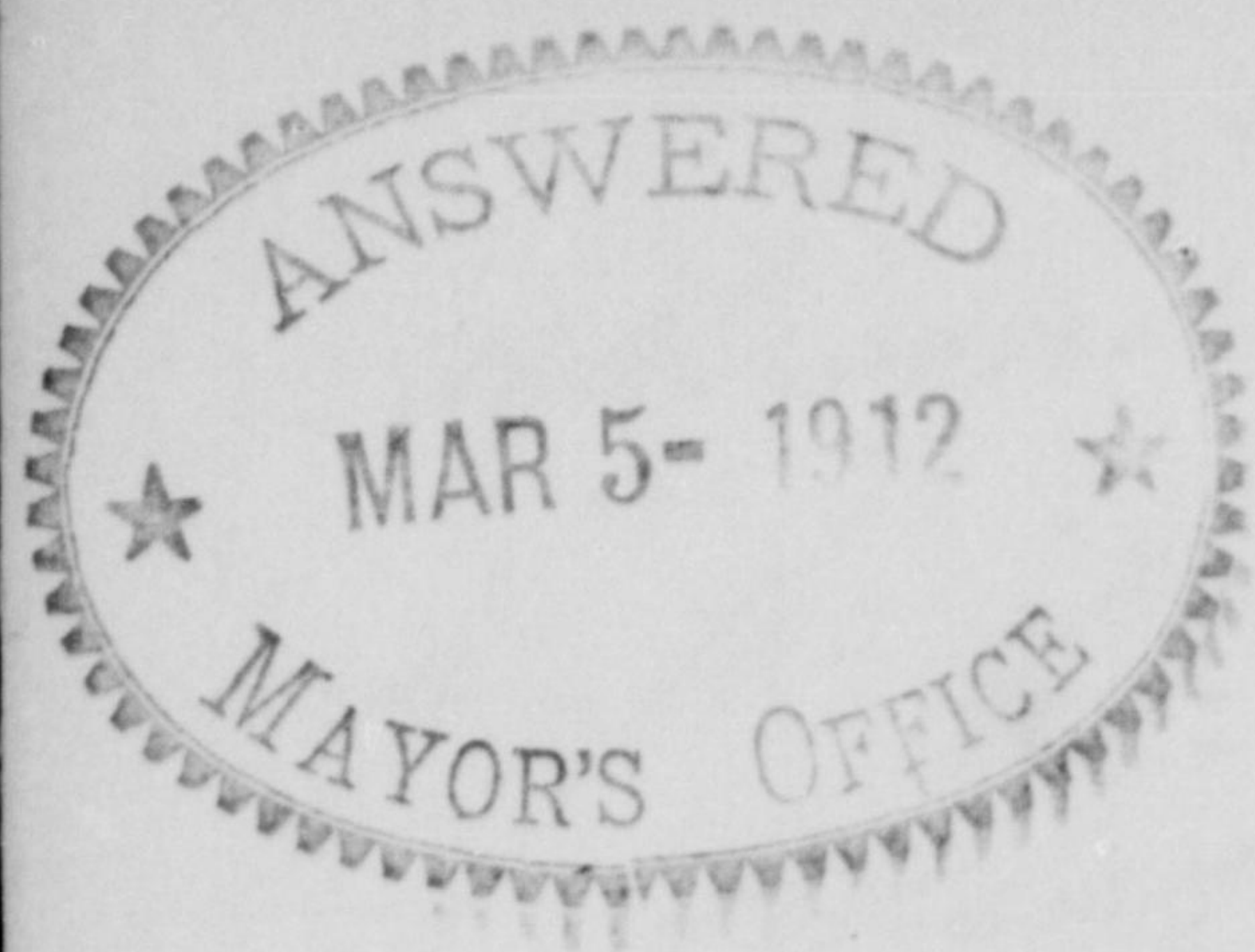

Dear Mr. Mayor:,

My attention has been called to a letter written by you to the Governor of this State, concerning the Brandt case, and given out for publication from Albany.

I recognize that you or any one else has a right to criticise any decision, but in this case your letter has been construed as a personal attack on me.

I might also call your attention to the fact that you state in your letter that Brandt's examination by the Judge took place on the day he was sentenced when as a matter of fact it took place on the day he was arraigned to plead.

So far as I know our relations have been friendly - but I cannot allow a letter which has been construed (whether rightfully or not) as ^{personal} an attack and which is written by one who is not only Mayor of our city but an ex-judge of this court, to pass without calling your attention to this construction which has been placed on it.,
