MEMORANDUM IN FAVOR OF AN ACT TO PROVIDE FOR THE
ESTABLISHMENT OF ROSE HILL PLACE, IN THE TWENTY-FOURTH
WARD OF THE CITY OF NEW YORK.

Statement of Facts.

This act provides that the triangular piece of land bounded by the depressed tracks of the New York and Harlem Railroad at Fordham, Pelham Avenue and Webster Avenue, shall be used as a public place, and gives the Commissioner of Street Improvements discretion to set apart a portion of it as an approach to the bridge and depot at Fordham station. This triangle was originally laid out as part of Vanderbilt Avenue West on the official maps of the City of New York and commissioners of estimate and assessment were appointed to acquire it as a public street. Subsequently it was laid out by the Commissioner of Street Improvements as a public place and is now so laid out. It consists of two narrow strips of land lying on either side of old Berrian avenue, which has been discontinued and closed and for which the commissioners have only made an award of one dollar. The whole cost of this triangle has been finally estimated by the commissioners at \$55,000. It now lies from 12 to 14 feet below the grade of Pelham avenue and the grade of Webster avenue.

P O I N T I.

Legislation was necessary in order to provide that that which was being acquired as a public street should be used as a public place and to save the report and the jurisdiction of the Commissioners of Estimate and Assessment.

To obviate the objection that, the use having been changed the commissioners no longer had jurisdiction it became necessary to apply to the Legislature for authority to change the use of this triangle from that of a public street to that of a public place.

Old Berrian avenue, which constitutes the greater portion of this triangle has been discontinued and closed, and a nominal award of one dollar has been made for this parcel on the assumption that the public right of way still continued over it.

To preserve this public right of way, it was necessary that it should be legally laid out again for some public use and that the Legislature should so authorize it. Otherwise a substantial award should have been made as on the closing it would have reverted to the abutting owners as private property.

P O I N T I I .

Special reasons exist for this legislation.

First. This is a public place ^{at} ~~and~~ one of the most important depots of the north side. There are only two other similar public places in the Twenty-third and Twenty-fourth Wards, both at the stations of the Harlem Railroad, one at Melrose and the other at Mott Haven. They were intended to be used as cab stands and for the benefit of ^{the} ~~each~~ community having occasion to use these depots.

Second. It is bounded on one side by the depressed ^{road} ~~tracks~~ of the Harlem Railroad which cannot be assessed for benefit, and on the other two sides by avenues

one hundred feet in width, the property bordering which has been so cut up by intersecting and parallel streets as to leave little area to assess for benefit (see accompanying diagram)

Third. The terminus of North Third Avenue at the Fordham College grounds turns all the traffic on North Third Avenue westerly to Webster avenue at this point, and vice versa.

On account of the sharp rise to the westward in the topography of this portion of the city there is practically only one avenue running north and south between Tremont and Woodlawn, to wit, Webster avenue, and at this point occurs the greatest amount of crossing in the 24th Ward. Further, at this point occurs the greatest amount of traffic east and west. Pelham avenue is the main route to the ~~Mount~~ Morris Park, to the Country Club, to Pelham and City Island, and most of the pleasure driving comes from ~~Sherman~~ ^{Pelham} and Sedgwick avenues down Fordham Hill and across the Harlem Railroad at this point. There is no such crossing for a mile north or south.

Fourth: The trolley cars cross from north Third Avenue to Webster avenue at this point and make a very ugly and dangerous turn (see accompanying diagram). There is only twenty feet of roadway now for the passage of carriages between the southerly sides of the tracks of the electric road and the southerly curb line of Pelham avenue. This act will enable the straightening of that ~~portion~~ ^{roadway} so that a greater width and a less dangerous condition of affairs will exist at this point.

P O I N T I I I .

As a matter of justice to the property owners this act should become a law.

When Pelham avenue was widened between the Harlem Railroad and Webster avenue and straightened, the law in existence at that time required that the cost of the land should be assessed on the property abutting. Consequently, under a resolution of the Board of Street Opening and Improvement the total expense of this improvement was assessed immediately upon the abutting property, resulting in an assessment of one thousand dollars a lot for the mere condemnation of the land. This injustice, owing to an arbitrary enactment of the legislature, has been so burdensome, that most of this assessment cannot be paid at present and the property owners were in some instances obliged to mortgage their property in order to pay the assessment and save the seven per cent penalty, whereas others are now paying the seven per cent penalty for non-payment of assessment.

P O I N T I V .

As a matter of expediency this act should become a law.

The Commissioners of Estimate and Assessment for the acquiring of this triangle have stretched their area of assessment half way to Williams Bridge and half way to Tremont in order to raise the cost of this improvement. This area of assessment is so obviously unjust, and the circumstances attending the widening of Pelham avenue were likewise so obviously unjust that the commissioners have resolved to recommend to the Board of Street Opening and Improvement that it should assume the

cost of this improvement.

It is inexpedient that such a course should be taken.

First. Because it sets a precedent for *Recommendations* ~~applications~~ of a similar kind in the future where no such special reasons occur.

Second. It sets a precedent for similar applications to the Board of Street Opening and Improvement.

As the Board meets once a week, and as the legislature only meets once a year, it is obvious that the best course to pursue is to confine these applications to the legislature and prevent them as much as possible from going before the Board of Street Opening and Improvement. Therefore a legislative enactment is much more desirable, as far as the City's interests are concerned, than an application directed to the Board of Street Opening and Improvement.

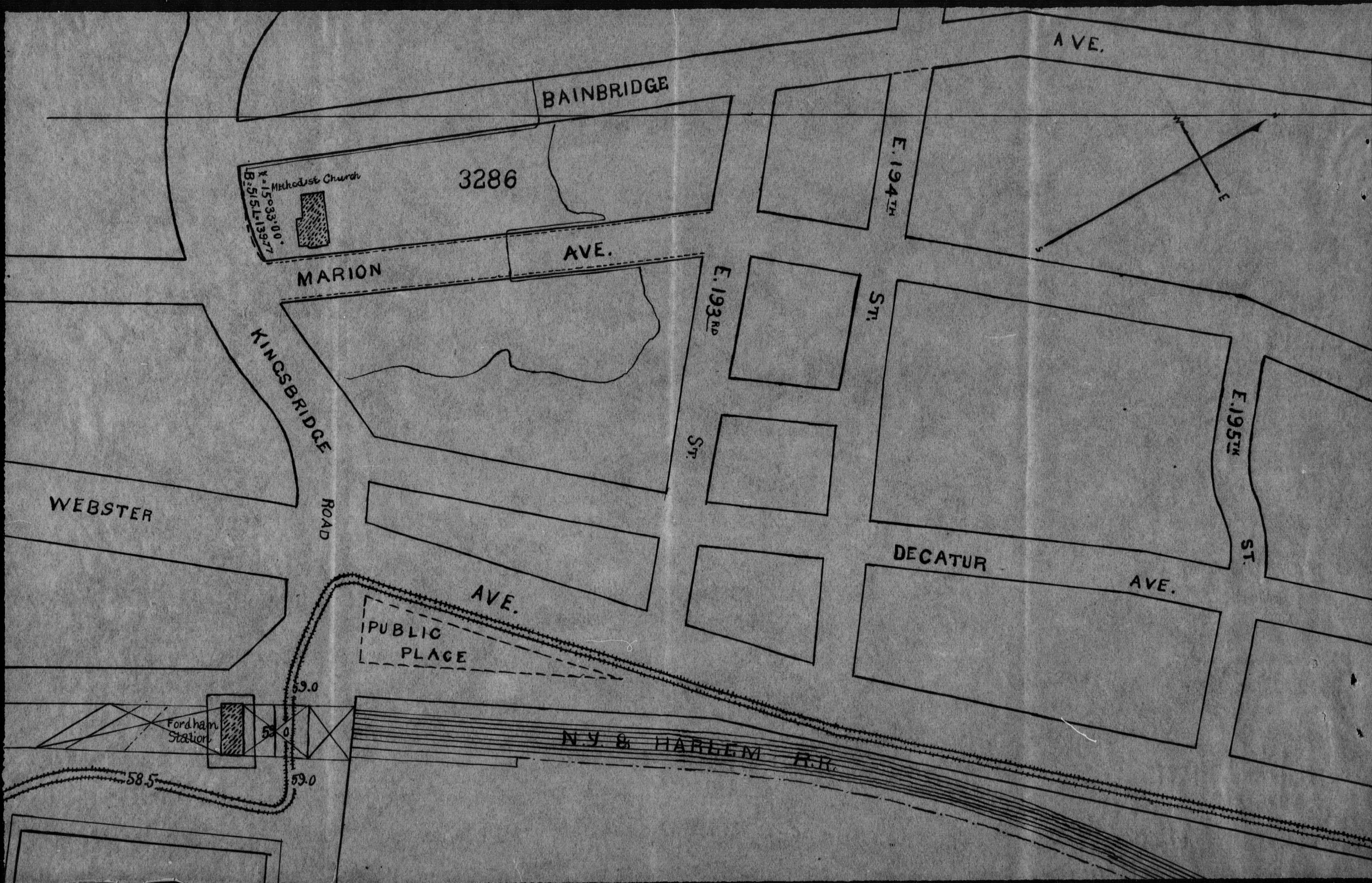
P O I N T V.

This public place can be regulated and graded at no ~~cost~~ *expense* to the City.

The Commissioner of street Improvements is about to let the contracts for the paving of Webster avenue from 184th street on the south to the Southern Boulevard on the north. The engineer of construction has informed me that the sub-grading of this avenue for the purpose of laying this pavement will furnish more than enough filling to complete the regulating and grading of this public place. It follows, therefore, that it will cost the City nothing to regulate and grade this public place.
