Went from 108 St + CP to 116 St + Snow Ave from 3:20 to 3:01 PM. It must take longer than that to make that trip. (178 St + Bklyn 2:25 PM to Bklyn + 156 St) 2 minutes. 2:27 PM. Yes it's possible. the time on the card is not always accurate. (115 St Snow 12:01 362 Snow Ave 12:51) the 12:51 PM - again. I make out trip card when I ride. Estimate on it. Show 80¢ fare 108 St + CP to 116 + Snow 3-14 to 3:01 PM 1 minute cost 80 cent, what I read I put down, yes it would seem impossible to drive for one minute and have an eighty cent fare driving in the city. I've received by the Hack Bus. for about 5 or 6 months. I did not attend the convention for much is in Chicago

religious instruction, & services. I have never taken  
training in karate or acted as security for anyone.  
I am a muslim. I am not a member of the Fruit  
of Islam. I have ~~been~~ been in the Audubon Ballroom  
only ~~once~~ for a Lazaar. I was at the Audubon  
Ballroom for a mosque #7 meeting about Feb 9 or 10  
a couple of weeks I imagine before Makohu x was  
shot. This meeting was a dinner. There were about  
500 people there. I don't remember seeing anybody  
there. I don't know how many there. I didn't stay for any  
speeches. I just stayed for dinner to pay my respects.  
I have no equal. I am not in charge of any men. Minister

I have been a member of the Muslims, and Mosque #7, since Feb. 1960. I HAVE NEVER BEEN A MEMBER OF THE OAAU. OR ATTENDED THEIR MEETINGS. In Feb. 1960 I lived at 325 Lenox Ave. NYC. I only attend religious services. I have never taken any training in karate or judo or ever acted as security for anyone. I am a member of the ~~Muslims~~ Muslims, I am NOT a member of the FRUIT OF ISLAM. I have been to the Audubon ballroom for a dinner given by mosque 7, on about Feb. 9, or 10, 1965. it was a tuesday. I imagine this dinner was a couple of weeks before Malcolm X was shot. There was about 500 people there. I didn't stay for any speeches and did not know if there were to be any. I just stayed for dinner arriving late, about 7:10PM and pay my respects. I left right after dinner. There were a few elderly people at my booth and I don't know them or didn't speak to them. I didn't see anybody. I didn't speak to anybody. I have no squad and I am not in charge of any men. Minister James is in charge of the mosque. I sell newspapers. I pick them up at the newspaper office myself. Sometimes the newspaper receipts were signed by Henry, or James 52X, I don't know of any rank in the organization. I don't know of Captain Joseph. No set amount of money is given, I give 10, 15, or 20 dollars whatever I can afford. I never heard of Shabazz industries. I was in the mosque 7 when Malcolm was the minister. After prayer I leave. I don't know of any speeches. Wednesday, Friday and Sunday the center is open. On Sunday we all pray together. NEVER ATTENDED MALCOLM X MEETINGS. AFTER HE LEFT MOSQUE 7. Whether anything was taught about malcolm X after he left mosque 7 I don't know. I drive a taxi part time on Saturday or Sunday sometimes. The last time I drove a taxi was last week Sunday. I know Norman 3X Butler and Thomas 15X Johnson from praying together with them. I don't know Butler or Johnson's function or if they have any. I never heard of Thomas Hagan or Talmadge Hayer before I read his name in the newspaper. (Shown photo) never saw this man before to my knowledge. I spend about an hour on Sunday at the mosque and just for prayer and then I leave. I DON'T KNOW ABOUT ANY SPEECHES. ON SUNDAY FEB. 21, 1965 I WAS DRIVING A TAXI. From about 7AM to 3:45 PM. I made out the trip card. To my knowledge my wristwatch was working and the taxi's meter was working all right. WHILE DRIVING MY TAXI ON FEB. 21, 1965 I DID NOT GO TO THE AUDUBON BALLROOM. EVERYTHING OF MY TRIP CARD IS THE TRUTH. I MADE IT OUT AS I WENT ALONG. (ASKED ABOUT TRIP CARD BY ADA STERN:) "It must take longer than one minute to go from 108 St. and Central Park West, to 116th St. and Lenox ave its 2 blocks and a traffic light that you must catch. The time on the card is NOT ALWAYS ACCURATE. I ESTIMATE ON TRIP CARD. IT DOESN'T SEEM POSSIBLE TO MAKE THE TRIP IN ONE MINUTE AND ALSO DOESN'T SEEM POSSIBLE IT WOULD BE 80 CENT FARE. YES THIS WOULD BE IMPOSSIBLE. I am licensed by the Hack Bur. for about 5 or 6 months, I did not attend the Chicago covenant this year. I PRAY AND LEAVE THE MOSQUE I DON'T KNOW ANYTHING ELSE ABOUT IT.
